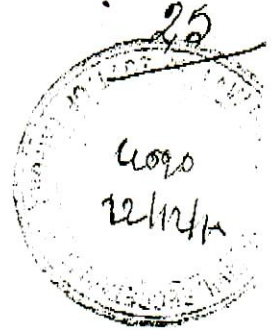

NOTIFICATION

In pursuance of the direction of the Hon'ble Supreme Court of India in paragraph 33(f) of the Judgment & Order dated 08.11.2016 passed in Voluntary Health Association of Punjab (Regd) Vrs. Union of India & Others (Writ Petition (Civil) Nos. 349 of 2006 & 575 of 2014), Hon'ble the Chief Justice of the High Court of Tripura has been pleased to order that henceforth all Courts trying cases under 'The Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994' within the jurisdiction of the High Court shall be treated as Fast Track Courts for purpose of trial of such cases and all such cases shall be disposed of within a time frame of one year from the date of institution of such case.
