

FOUR ACCUSED CONVICTED IN A HURT & ASSAULT CASE BY THE LD. CHIEF JUDICIAL MAGISTRATE, UDAIPUR, GOMATI TRIPURA.

Today, On 02-02-2016, LD. Chief Judicial Magistrate, Udaipur, Gomati Tripura, has convicted 04 (Four) accused persons namely (1) Abhijit Das @ Abhi S/O Sri Adhir Ch. Das (2) Sri Abhadananda Nag (23) S/O Sri Maran Nag (3) Sri Rajesh Das (20) S/O Sri Kanu Rn. Das (4) Sri Biswajit Biswas @ Sagar (22) S/O Sri Gouranga Biswas all of No-01 Fulkumari (Cannel Chowmahani), PS- R.K.Pur, Gomati District, U/S- 341/323/34 IPC.

On 18-02-2015, R.K.Pur PS Case No. 22/2015 U/S- 341/325/34 IPC, was registered on the basis of written compliant of one Sri Prasenjit Roy S/o Sri Nandalal Roy of Town Fulkumari Ward- 19, PS R.K.Pur under Gomati District against the accused persons namely (1) Abhijit Das @ Abhi S/O Sri Adhir Ch. Das (2) Sri Abhadananda Nag (23) S/O Sri Maran Nag (3) Sri Rajesh Das (20) S/O Sri Kanu Rn. Das (4) Sri Biswajit Biswas @ Sagar (22) S/O Sri Gouranga Biswas all of No-01 Fulkumari (Cannel Chowmahani), PS- R.K.Pur, Gomati District; for hurling attack and assault upon the complainant & his friend On 17-02-2015 at West bank of Dhanisagar Near (Kar Varieties), PS R.K.Pur.

After investigation, charge sheet was filed by SI Biswajit Das, On 31-03-2015, against the accused persons namely (1) Abhijit Das @ Abhi S/O Sri Adhir Ch. Das (2) Sri Abhadananda Nag (23) S/O Sri Maran Nag (3) Sri Rajesh Das (20) S/O Sri Kanu Rn. Das (4) Sri Biswajit Biswas @ Sagar (22) S/O Sri Gouranga Biswas all of No-01 Fulkumari (Cannel Chowmahani), PS- R.K.Pur, Gomati District, vide R.K.Pur PS C/S No. 32/2015 U/S 341/323/325/34 IPC.

The trial Court on appreciation of evidence found the accused persons namely (1) Abhijit Das @ Abhi (2) Sri Abhadananda Nag (23) (3) Sri Rajesh Das (20) (4) Sri Biswajit Biswas @ Sagar (22) all of No-01 Fulkumari (Cannel Chowmahani), PS- R.K.Pur guilty of offence punishable U/S- 341/323/34 IPC. Considering the nature of case the Ld. Court released the convict person U/S 4 of Probation of offender Act 1958 for good conduct instead of sentencing the A/Ps at once to any punishment on their execution of bond with one security of Rs 10,000/- to appear & receive sentence when call upon during the period of 02 (two) years, in the mean time to keep the peace and be of good behavior.
