

FOUR ACCUSED CONVICTED IN A HURT & ASSAULT CASE

Today, On 02-03-2016, LD. Judicial Magistrate, 1st Class, Amarpur, Gomati Tripura, has convicted 04 (Four) accused persons namely (1) Nirmal Das (24) S/O Sri Nikesh Lal Das. (2) Nikesh Lal Das (55) S/O Lt. Monmohan Das (3) Smt. Pranati Das (50) W/O Sri Nikesh Lal Das (4) Laxmirani Shil (Das) (22) W/O Sri Nirmal Das all of Bampur Market, PS Birganj , Gomati District, U/S- 332 IPC.

On 21-12-2014, Birganj PS Case No. 71/2014 U/S- 353/333 IPC, was registered on the basis of written compliant of one Shri Shyamal Das, ASI of Police, PS Birganj under Gomati District against the accused persons namely (1) Nirmal Das (24) S/O Sri Nikesh Lal Das. (2) Nikesh Lal Das (55) S/O Lt. Monmohan Das (3) Smt. Pranati Das (50) W/O Sri Nikesh Lal Das (4) Laxmirani Shil (Das) (22) W/O Sri Nirmal Das all of Bampur Market, PS Birganj, Gomati District; for hurling attack and assault upon the complainant & his staff On 21-12-2014 at Bampur (Market), PS BRG.

After investigation, charge sheet was filed by SI Samar Das, On 31-12-2014, against the accused persons namely (1) Nirmal Das (24) S/O Sri Nikesh Lal Das. (2) Nikesh Lal Das (55) S/O Lt. Monmohan Das (3) Smt. Pranati Das (50) W/O Sri Nikesh Lal Das (4) Laxmirani Shil (Das) (22) W/O Sri Nirmal Das all of Bampur Market, PS Birganj, Gomati District, vide BRG PS C/S No. 55/2014 U/S 353/332/120 (B) IPC & 45 T.E Act.

The trial Court on appreciation of evidence found the accused persons namely (1) Nirmal Das (24) (2) Nikesh Lal Das (55) (3) Smt. Pranati Das (50) (4) Laxmirani Shil (Das) (22) all of Bampur Market, PS Birganj, is guilty U/S 332 IPC and sentenced to suffer R.I for a period of 02 (Two) years and to pay a fine of Rs- 1000/- i.d to payment S.I for 20 (Twenty) days for each. Convict Nirmal Das is further sentenced to suffer R.I for 03 (Three) Months & to pay a fine of Rs- 1000/- i.d to payment S.I for 15 (Fifteen) days for the commission of offence punishable U/S 45 T.E Act.
