

FOUR ACCUSED CONVICTED IN A HURT & ASSAULT CASE

Today, On 16-03-2016, LD. Chief Judicial Magistrate Udaipur, Gomati Tripura, has convicted 04 (Four) accused persons namely (1) Md. Abdul Chadak S/O Md. Habil Miah (2) Md. Tajer Miah @ Tajju S/O Md. Habil Miah (3) Md. Nurul Hossain @ Nur S/O Md. Habil Miah (4) Md. Hanif Miah S/O Lt. Renu Miah all of East Khupilong PS Killa, Gomati District, U/S- 448/323 IPC.

On 05-04-2014, Killa PS Case No. 11/2014 U/S- 457/354/325 IPC, was registered on the basis of written complaint of one Smti Mafiya Khatun (35) W/O Md. Kabir Miah of East Khupilong PS Killa under Gomati District against the accused persons namely (1) Md. Abdul Chadak S/O Md. Habil Miah (2) Md. Tajer Miah @ Tajju S/O Md. Habil Miah (3) Md. Nurul Hossain @ Nur S/O Md. Habil Miah (4) Md. Hanif Miah S/O Lt. Renu Miah (5) Siru Miah S/O Md. Habil Miah all of East Khupilong PS Killa, Gomati District; for hurling attack and assault upon the wife of complainant on 23-03-2014 at about 2100 hrs. at East Khupilong, Under PS Killa.

After investigation, charge sheet was filed by Inspector Hemanta Debbarma, On 19-06-2014, against the accused persons namely (1) Md. Abdul Chadak S/O Md. Habil Miah (2) Md. Tajer Miah @ Tajju S/O Md. Habil Miah (3) Md. Nurul Hossain @ Nur S/O Md. Habil Miah (4) Md. Hanif Miah S/O Lt. Renu Miah all of East Khupilong PS Killa, Gomati District, vide Killa PS C/S No. 14/2014 U/S 457/354/325 IPC.

The trial Court on appreciation of evidence found the accused persons namely (1) Md. Abdul Chadak (2) Md. Tajer Miah @ Tajju (3) Md. Nurul Hossain @ Nur (4) Md. Hanif Miah all of East Khupilong PS Killa, Gomati District is guilty U/S 448/323 IPC. and sentenced them to pay a fine of Rs- 300/- each i.d of payment S.I for 01 (One) Month for the commission of punishable U/S 447/34 IPC. and also sentenced them to pay a fine of Rs- 700/ each i.d of payment to suffer S.I for 04 (Four) months for the commission of punishable U/S 323/34 IPC. Both the sentence shall run concurrently.
