

**THREE ACCUSED CONVICTED IN A HURT & ASSAULT CASE BY THE LD. JUDICIAL MAGISTRATE 1<sup>ST</sup> CLASS COURT NO. 02 UDAIPUR, GOMATI TRIPURA.**

Today, On 19-01-2016, Ld. Judicial Magistrate 1<sup>st</sup> Class Court No. 02 Udaipur, Gomati Tripura, has convicted 03 (Three) accused persons namely (1) Sunil Sukladas S/O Lt. Raj Mohan Sukladas (2) Pintu Sukladas S/O Sunil Sukladas (3) Ranjit Sukladas S/O Lt. Gouranga Sukladas all of Khilpara near School, PS- R.K.Pur Gomati District, U/S- 448/326/384/34 IPC.

On 17-08-2013, R.K.Pur PS Case No. 292/2013 U/S- 448/326/384/34 IPC, was registered on the basis of written compliant of one Sri Laxman Sutradhar S/o Lt. Gobinda Sutradhar of Khilpara, PS R.K.Pur under Gomati District against the accused persons namely (1) Sunil Sukladas S/O Lt. Raj Mohan Sukladas (2) Pintu Sukladas S/O Sunil Sukladas (3) Ranjit Sukladas S/O Lt. Gouranga Sukladas (4) Maran Sukladas S/O Sunil Sukladas (5) Smt. Dipali Sukladas W/O Sunil Sukladas (6) Smt. Anjali Sukladas W/O Lt. Khagendra Sukladas all of Khilpara near School, PS- R.K.Pur. Gomati District; for hurling attack and assault upon the wife of complainant and his Son On 17-08-2013 at Khilpara, PS R.K.Pur.

After investigation, charge sheet was filed by SI Subash Mallik, On 29-10-2013, against the accused persons namely (1) Sunil Sukladas S/O Lt. Raj Mohan Sukladas (2) Pintu Sukladas S/O Sunil Sukladas (3) Ranjit Sukladas S/O Lt. Gouranga Sukladas all of Khilpara near School, PS- R.K.Pur. Gomati District, vide R.K.Pur PS C/S No. 303/2013 U/S 448/323/325/34 IPC.

The trial Court on appreciation of evidence found the accused persons namely (1) Sunil Sukladas (2) Pintu Sukladas (3) Ranjit Sukladas all of Khilpara near School, PS- R.K.Pur guilty of offence punishable U/S- 448/326/384/34 IPC. Considering the nature of case the Ld. Court released the convict persons U/S 4 of Probation of offender Act 1958 for good conduct instead of sentencing the A/Ps at once to any punishment on their execution of bond with one security of Rs 10,000/- each & to appear & receive sentence when call upon during the period of 03 years, in the mean time to keep the peace and be of good behaviour.
