Today, On 25-02-2016, LD. Judicial Magistrate 1<sup>ST</sup> Class Court No- 02, Gomati Tripura, Udaipur, has convicted 07 (Seven) accused person namely (1) Md. Ayob Ali (35) S/O Lt. Sundar Ali (2) Md. Rakman Miah (24) S/O Lt. Hossain Ali (3) Md Hajar Ali @ fazar S/O Lt. Hossain Ali (4) Smt. Monoyara Bibi S/O Md. Ayob Ali (5) Smt. Surjyabhan Bibi W/O Lt. Hossain Ali (6) Md. Billa Miah (21) S/O Md. Nekbar Ali (7) Md. Karam Ali (19) S/O Md. Sayed Ali, all of Garjanmura PS- Kakraban under Gomati District U/S- 354/323 IPC.

On 06-09-2011, Kakraban PS Case No. 143/2011 U/S- 147/148/149/447/427/379 IPC, was registered on the Court compliant of one Anowar Ali S/O Lt. Sundar Ali of Bandowar (Amtali), PS- KKB, under Gomati District against the accused persons namely (1) Md. Ayob Ali (35) S/O Lt. Sundar Ali (2) Md. Rakman Miah (24) S/O Lt. Hossain Ali (3) Md Hajar Ali @ fazar S/O Lt. Hossain Ali (4) Smt. Monoyara Bibi S/O Md. Ayob Ali (5) Smt. Surjyabhan Bibi W/O Lt. Hossain (6) Md. Billa Miah (21) S/O Md. Nekbar Ali (7) Md. Karam Ali (19) S/O Md. Sayed Ali, all of Garjanmura PS- Kakraban under Gomati District; for hurling attack and assault upon the complainant on 19-08-2011 at about 0800 hrs at Badowar (Amtali) under Kakraban PS.

After investigation, charge sheet was filed by SI Ranjit Das on 31-10-2011, against the accused persons namely (1) Md. Ayob Ali (35) S/O Lt. Sundar Ali (2) Md. Rakman Miah (24) S/O Lt. Hossain Ali (3) Md Hajar Ali @ fazar S/O Lt. Hossain Ali (4) Smt. Monoyara Bibi S/O Md. Ayob Ali (5) Smt. Surjyabhan Bibi W/O Lt. Hossain Ali of Bandowar ( Amtali) PS KKB (6) Md. Billa Miah (21) S/O Md. Nekbar Ali (7) Md. Karam Ali (19) S/O Md. Sayed Ali, both of Garjanmura PS- KKB under Gomati District; vide Kakraban PS C/S No.149/2011 U/S- 148/149/447/427 IPC.

The trial Court on appreciation of evidence found the accused person namely (1) Md. Rakman Miah (24) (2) Md Hajar Ali @ fazar (3) Smt. Surjyabhan Bibi (4) Smt. Jalahha Bibi @ Monoyara Bibi (5) Md. Billa Miah (21) (7) Md. Karam Ali (19) (7) Md. Ayob Ali (35) all of Garjanmura PS- KKB under Gomati District, are convicted and taking into account the gravity of the offence and also finding that there is noting on record to show that the convicts have been previously convicted, they are admonished under section 3 of probation of offenders act. They are warned and are asked not to involve in sort of criminal activity and so maintain good conduct and after due admonition they are released.
