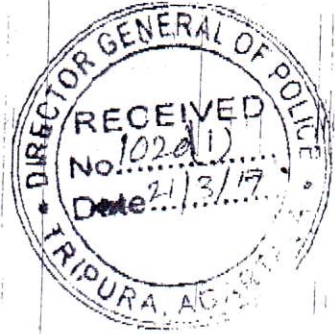

ORDER

WHEREAS the State Government is satisfied that circumstances exist in the State for which it is necessary to direct the competent authorities to exercise the powers conferred under Sub Section (2) of Section 3 of the National Security Act, 1980;

NOW, THEREFORE, in exercise of the powers conferred by Sub-Section (3) of Section 3 of the National Security Act, 1980, the State Government hereby directs that the District Magistrates & Collectors, West Tripura, Agartala / Shipahijala, Bishramganj / Khowai / Gomati, Udaipur / South Tripura, Belonia / Dhalai, Ambassa / Unakoti, Kailashahar / North Tripura, Dharmanagar shall exercise the powers given under Sub Section (2) of Section 3 of the said Act in their respective jurisdiction for a further period of 3 (three) months with effect from 29th March, 2017 to 28th June, 2017.

This order shall come into force w.e.f. 29th March, 2017.


